◆健康保険の保険料率は104/1000(被保険者52/1000、事業主52/1000)です。

- 内訳 {
- ・基本保険料率 63.878/1000 (健康保険の医療給付や保健事業等に充てる保険料)
 - ・特定保険料率 38.952/1000 (高齢者等の医療を支える費用として拠出する保険料)
 - ・調整保険料率 1.17/1000 (健康保険組合間の共同事業に充てる保険料)

◆介護保険の保険料率は17/1000(被保険者8.5/1000、事業主8.5/1000)です。

介護2号被保険者(満40歳~65歳未満)以外の被保険者は、健康保険料のみとなります。

◆ボーナス時の保険料は標準賞与額(1000円未満の端数を切捨てた額)に保険料率を乗じた額です。

(標準賞与額の上限は、年間573万円(4月1日から翌年3月31日までの累計額)です。)
